

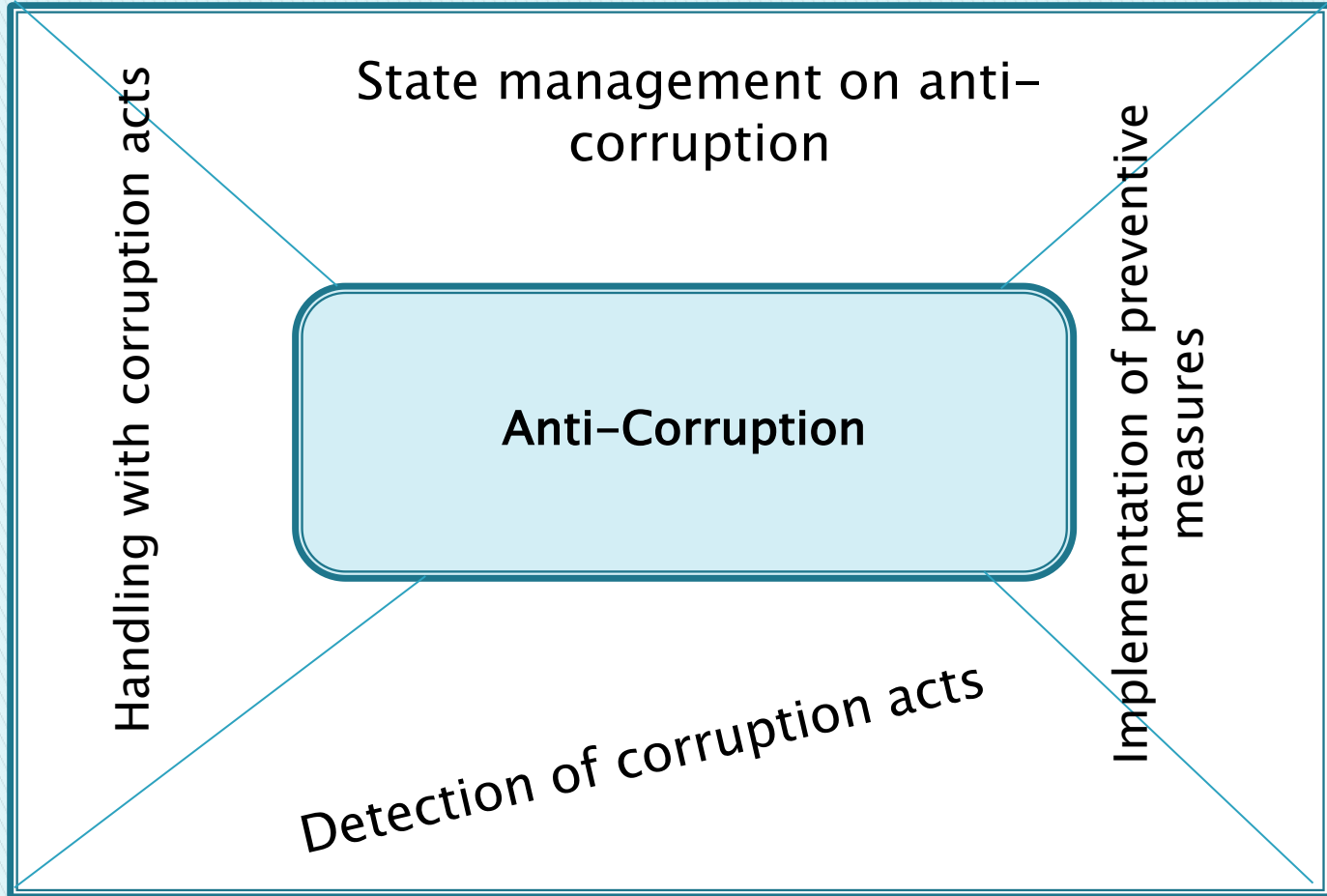

Overview of Anti-Corruption in Vietnam



1. State management on anti-corruption (Progress)

Institutional improvements on anti-corruption

- Amend and promulgate 2018 Anti-Corruption Law (Law No. 36/2018/QH14)
- Decree guiding implementation (Decree 59/2019/ND-CP)
- Decree on controlling asset and income of persons with positions and powers in agencies, organizations, units (Decree130/2020/ND-CP).

Propaganda and dissemination of anti-corruption laws

- ▶ Implementation of the project to propagate the anti-corruption law
- ▶ Include anti-corruption content in education levels
- ▶ Innovate and diversify propaganda forms
- ▶ Strengthen the role of the media ...

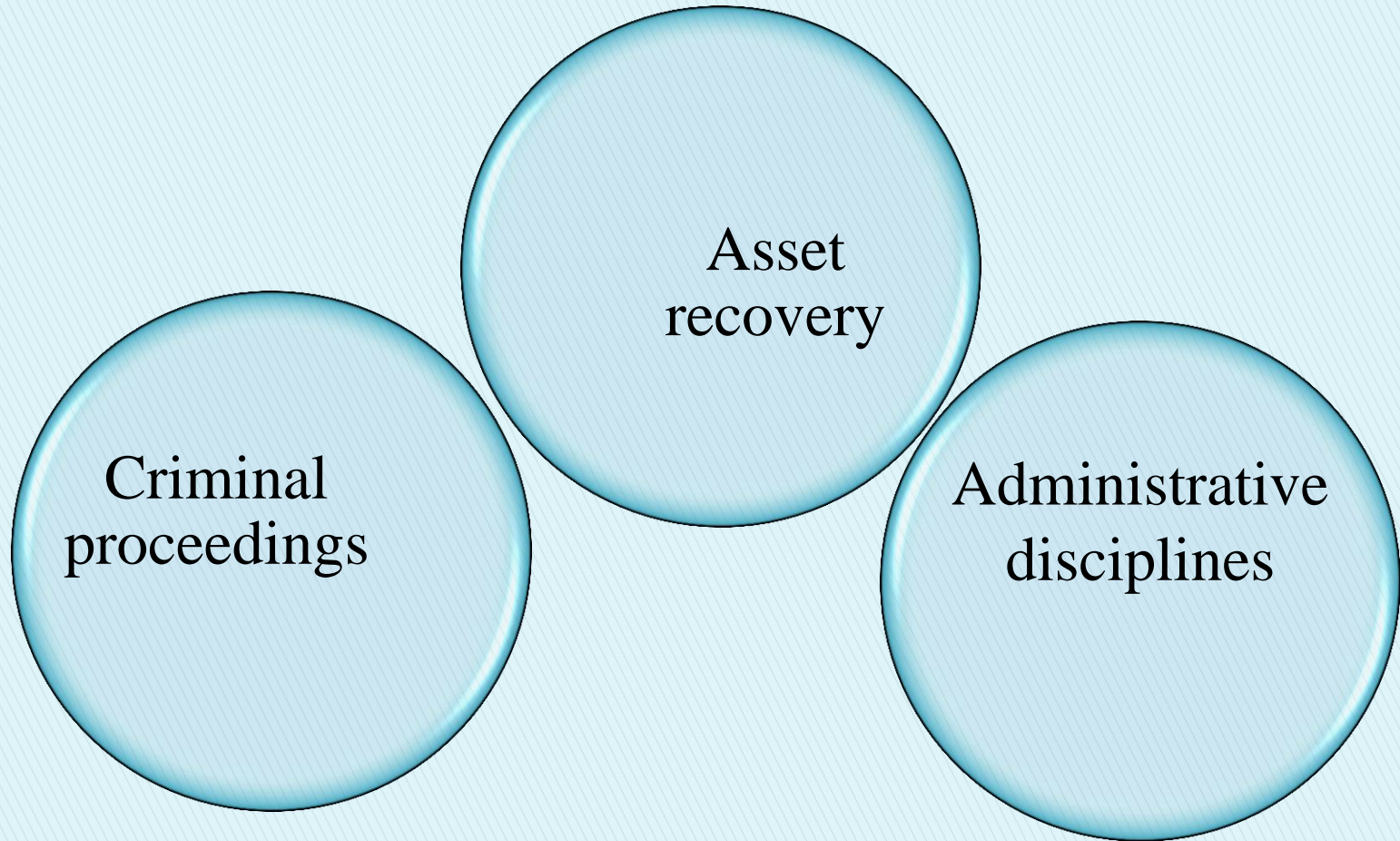
2. Implementation of preventive measures

- ▶ Development of a National Database Project on controlling assets and income
- ▶ Control corruption in the national development strategic governance indicator system
- ▶ Completion of UNCAC self-assessment report
- ▶ Strengthen openness, transparency, and accountability in state agencies

Major achievements (2019-2020)

Inspection, complaints and denunciation handling

- ▶ **24,275** complaints and denunciations under jurisdiction, reaching 83.5% rate resolved
- ▶ Conduct 217,074 inspections
- ▶ Detect violations **119.528** billion VND, **9.045** ha of land
- ▶ Propose to recover 44,582 billion VND and over 1,401 ha of land
- ▶ Recommendations for disciplinary action of **2,656 collectives and many individuals**; to transfer to the investigation agency to handle 155 criminal cases, 135 subjects.

Handling of corrupt behaviors

Public Security

- ▶ Investigating **535 cases**, **1,249 accused** of corruption
- ▶ Proposed prosecution of **253 cases**, **760 defendants** (by 2020)

Prosecutors

- Supervision and investigation of **845 cases / 1596 accused**
- Resolving **390 cases / 827 defendants**.

Handling of corrupt behaviors

People's courts at all levels

- ▶ Accepted first instance 436 cases with 1,175 defendants;
- ▶ First instance trial of 269 cases, 645 defendants
- ▶ 08 defendants were sentenced to life imprisonment or higher; appellate trial of 158 cases, 326 defendants.

Asset Recovery:

Ending 3,605 cases, the amount: 15,017.9 billion

A number of results

- ▶ Tens of thousands of people were disciplined,
- ▶ **92** high-ranking cadres, general in public justice, the military;
- ▶ Criminal handling of hundreds of people holding high positions, including **6** people who used to hold the position of minister or higher
